1. All applicants for membership of the Club who do not hold a current Firearms Certificate must serve a minimum 3 month probationary period.
2. Please note that it is not unusual for the probationary period to be extended (on more than one occasion) for various reasons, for example to allow the Committee to better assess the suitability of applicants over a longer period. Please could all applicants bear this in mind – an extension of the probationary period is not necessarily a reflection on the suitability of the applicant, but may be related to other factors.
3. Under Club rules, the minimum 3 month probationary period also applies to applicants who do hold a current Firearms Certificate, though the probationary period may be waived (in writing and not otherwise) at the sole discretion of the Committee if the probationary member has a current Firearms Certificate and is already a full member of another full-bore rifle club who is known to the Committee.
4. In all cases, the Committee is entitled at its sole discretion and at any time (a) to reject any application for probationary membership of the Club, (b) to suspend or revoke the status of probationary membership in relation to any probationary member, and (c) to reject any application by a probationary member to become a full member of the Club.
5. The Committee need not give reasons for taking any of the actions referred to at paragraph 4 above and there is no right of appeal.
6. By submitting this Membership Application Form, to the fullest extent permitted by law, applicants for membership of the Club irrevocably waive any rights and claims they might have against the Committee, the Club and/or any member or Officer of the Club in relation to the actions referred to at paragraph 4 above.
